Acceptance criteria

Ordinary member

Ordinary members of the society are licensed doctors of medicine and at the same time specialists in one of the following disciplines: Gynaecology, plastic surgery, surgery, dermatology or urology.

Proven experience in the area of aesthetic and reconstructive medicine/research, is a requirement for acceptance. Ordinary members are entitled to vote and liable to contribute.

- A membership from another specialist medical area or association is possible. You have no right to vote, but have reduced liability to contribute.

Requirements for acceptance as an ordinary member are:

- Tabular CV
- Positive vote from a guarantor, who is already an ordinary member of the association.
- Positive vote from 75% of the board members

Supporting member

- Business enterprises, that support the aims of the association can be accepted as supporting members. You have no right to vote, but have liability to contribute.

One off enrolment fee: €250

Annual membership amount: €1500

Extraordinary member

Requirements for acceptance as an extraordinary member are:

- Education or further education in medicine (assistant physician or physician in training)
- Tabular CV
- Positive vote from a guarantor, who is already an ordinary member of the association.
- Positive vote from 75% of the board members

Or

- Persons who have been suggested due to their importance for the society by the board.
(Journalists, activists, social establishments and civil organisations etc.)

Extraordinary members with the status (doctor in training) have no right to vote and will not be accepted into the list of doctors on the homepage www.irsrait.org.
